Greetings:

I'm writing you today to proudly announce that ContainMed, Inc. is moving operations to our new 130,000 square foot home, 16 miles from our current location. This increased space will allow for expansion of operations, and improved process and material flow, compared to our current facility. We have long term plans for this property that will allow us to in-house more of our operations to better serve the needs of our customers, as well as expanding our offerings and capabilities. On day one, we will immediately occupy approximately 70,000 square feet of manufacturing space, a 7x increase from our current facility. We have ample growth potential in this facility, as well as the ability to build additional resource as needed, ensuring our facility can handle all levels of growth in the coming years.

We began planning this move in September of 2019, originally intending for it to occur in March of 2020. However, like many things in 2020, that did not go exactly to plan. Nevertheless, we continued developing our risk mitigation strategies for the move, and ultimately produced a robust, carefully calculated plan to move operations with minimal disruption in service.

I'm proud to report the first phase of our plan commenced with non-fabrication operations ending as scheduled at the close of business on Friday the 11th, and beginning in our new facility at the open of business on Monday the 14th. Fabrication on any order placed prior to today has been completed. New orders not already received, will not begin manufacture until after our IQ/OQ/PQ process has been completed. Our fabrication department ceased operations at close of business on the 16th, and will resume fabrication activities on the 21st, with re-validation of special processes being completed in the first week of January.

Coming at year end, and the holiday season, we are confident that our move will have virtually zero impact on our ability to serve customer needs, and once complete, will improve our processes, throughput, capacity, and capabilities.
